**Agreement of Co-operation
Between**

**Faculty for Montenegrin Language and Literature
and
Institute of Language**

Considering that achievements of wider international co-operation academic programmes realized through dissemination and advancement of knowledge and ideas, as well as promotion of transdisciplinary and interdisciplinary approaches which become of vital importance for socio-cultural and economic development.

Recognizing benefits of mobilization and partnership of scholars and institutions from various parts of the world, which is based on mutual respect and credibility in their service to public good.

With the objective of promoting co-operation both in academic education and research the following Agreement is established:

This Agreement is made and entered into on the date of the final signature hereto, by and between the Faculty for Montenegrin Language and Literature and the Institute of Language

Article 1

The co-operation may concern any field or subject upon which the parties agree. It will include various activities, such as:

- Collaborative research, lectures and symposia,
- Exchange of scholars and researchers,
- Exchange of students and
- Exchange of information, books, publications and materials in fields, which are of interest to both parties.

Article 2

Each institution will be responsible for seeking funds to support its involvement in the cooperative activities contemplated under this Agreement, and all such activities will be dependent upon the budgetary appropriations of the parties.

Implementation of the activities contemplated by this Agreement depends upon the ability of the parties to successfully secure adequate funding to support the activities.

Article 3

This Agreement is subject to revisions, renewal and/or cancellation by mutual written consent.

Article 4

All results, as an outcome of the co-operation will be dealt with in the following way:

- the patents invented will continue to belong to the Faculty that originated them.

Article 5

This Agreement is written and signed in English in two copies, of which both sides receive one copy of the Agreement. This Agreement will be in effect for a period of five (5) years from the date of execution and may be renewed for additional five (5) year periods by the parties. Either party giving ninety days written notice to the other party may terminate the Agreement provided that such termination will not effect the completion of any activity underway at the time.
